

Okinawa Institute of Science and Technology Graduate University's basic policy for  
dealing with novel coronaviruses

As of November 2021, the state of emergency in Japan has been lifted, the peak of the infection has subsided, and daily life seems to have returned to normal. However, if we look at the world, the situation is not yet under control, and we cannot allow ourselves to be too optimistic. Under these circumstances, the Okinawa Institute of Science and Technology Graduate University (OIST) is in the process of resuming daily activities as much as possible while taking all possible measures to prevent infection.

To achieve this, the following is our basic policy.

- 1 OIST restores a place where faculty, staff, students, and others can feel safe in their daily lives and find many opportunities and meaning through learning, research, activities, and working at OIST.
- 2 OIST faculty, staff, students, and stakeholders will engage in dialogue and collaborate to promote specific actions in a timely fashion.
- 3 In principle, infection control at OIST will follow the policies of the Okinawa Prefectural Government. However, sufficient consideration will be given to the international nature and diversity of OIST.
- 4 OIST recommends that all personnel, including contractors, take basic infection prevention measures based on the “New Normal” and be vaccinated or PCR tested. However, OIST will make every effort to ensure no discrimination, exclusion, deprivation of opportunities, or other disadvantages due to the inability to receive vaccinations or PCR tests due to various reasons, including physical conditions.
